Triploid Grass Carp:

The NYS Department of Environmental Conservation requires a special permit to stock Triploid Grass Carp - identifying the specific pond and aquatic vegetation problem. (The application process takes 3-4 weeks.) If you order Grass Carp you will need to bring 3 copies of your DEC license.

Please note: Fish Program Pickup is Thursday, May 23, 2024 at 3PM at the Ontario County Soil & Water Conservation District 480 North Main Street Canandaigua in the parking lot. You must be able to pick up your fish at this time.

- If picking up grass carp, please bring DEC license (3 copies)
- Bring your own pond water and use the following guide:
- 2-4" 100 fish per 30 gallons of pond water
- 4-6" 75 fish per 30 gallons of pond water
- 10-14"- 5 fish per 30 gallons of pond water
